 - Crosswood, Inc. will pay 50% of the coverage for the one additional family member
 - Employees will pay 50% of coverage for the one additional family member
- □ For a full-time employee plus two or more receiving coverage:
 - Crosswood, Inc. will pay 100% of the coverage for the employee
 - Crosswood, Inc. will pay 60% of the coverage for the additional family members
 - Employees will pay 40% of the coverage for the additional family members
